**IMPORTANT NOTICE**

The Barbados Kennel Club will NOT accept applications for registration of litters:

- (a) If the dam is age 8 years or over at date of whelping OR
- (b) If the dam has previously whelped 6 or more litters OR
- (c) If the dam was under 1 year old at time of mating OR
- (d) If the sire was under 9 months old at time of mating.

**INTRODUCTION**

This form should be used by the breeder to register all puppies in a litter by name and must be submitted within 6 months of the date of birth. Any puppies omitted from this form will only be considered for subsequent registration at the discretion of the Barbados Kennel Club committee.

**NOTES FOR GUIDANCE**

- (1) The breeder is the owner of the dam at the date of whelping. The name(s) inserted on the form must be exactly the same as that shown on the registration certificate of the dam, unless registration has been effected under the Barbados Kennel Club Regulations for loan or use of bitch for breeding purposes. In the case of joint ownership all the names should be given.
- (2) The owner(s) of the sire at the date of mating should be given and in the case of joint ownership, all the names should be given. The details should be exactly the same as those shown on the registration certificate of the sire.
- (3) The declaration must be signed by all the parties having ownership of the dam.
- (4) The confirmation of mating must be signed by all the parties having ownership of the sire.
- (5) The registered names of the dam and of the sire should be exactly as shown on the registration certificate issued by the Barbados Kennel Club.
- (6) The Barbados Kennel Club registration numbers for the dam and the sire should be exactly as shown on the Barbados Kennel Club registration certificate.
- (7) The breed of the dog must be shown and should be quoted on all correspondence.
- (8) Breeders who have an affix should enter the affix in this box.
- (9) The date of birth of the litter and the date of mating must be related and this application will be returned if the dates appear to be incorrect.
- (10) The number of dogs and number of bitches in the litter must correspond in total with the individual details in the section in which the dogs are named.
- (11) It should be noted that all the dogs in the litter must be named at this stage. The Barbados Kennel Club will allocate names to all the dogs in the litter if this information is not given by the breeder. After the dogs have been named by the Barbados Kennel Club the names cannot be changed except by the addition of an affix.

**GUIDELINES FOR NAMING DOGS**

- (12) When inserting the names of dogs on the form please bear in mind the following:-
  - (a) A name must consist of more than one word but not more than 24 letters including affix (if any). Note, an affix is a word, which upon application, is granted by the committee and is reserved for the sole use of the affix holder(s) in the naming of dogs. It is not necessary to have an affix in order to register a litter.

- (b) An identical name already used within a breed cannot be used again unless ten years have elapsed since the name was previously allowed. It can be used as part of a name in conjunction with an affix or another word, making it unique, e.g. "Sunny Jim".
  - (c) If the name has been entered into the Stud Book, that name will not be accepted within that breed again.
  - (d) A name which conflicts with an approved and current affix granted to another person will not be accepted.
  - (e) The surname of the applicant is not acceptable.
  - (f) The name should begin with a single lettered word.
  - (g) Initials cannot be used and abbreviations may be disallowed.
  - (h) Numbers in figures are not acceptable. Numbers in words are acceptable.
  - (i) Punctuation marks may be disallowed.
  - (j) Canine terms are not permissible. For example, "dog", "bitch", "kennel", "Champion", names of breeds.
  - (k) If an affix is to be used when registering a litter, the affix must appear as the first word in the name. Please note that at a later date the new owner of a dog may add his own affix, if he has one, to the end of the dogs name. If the owner of the dog is the owner of its sire and the breeder of its dam his affix may be added to the front of the name. If the breeder does not wish an affix to be added at that time, he may request The Barbados Kennel Club to endorse the registration "name unchangeable" (see note 13).
  - (l) It is not advisable to use words from a Dog's Pedigree. These may include affixes (and may therefore not be acceptable). The Barbados Kennel Club will not accept a name which may be similar to an existing name and which may cause confusion.
  - (m) The Barbados Kennel Club reserves the right to refuse any name which it considers inappropriate or offensive.

**ENDORSEMENTS**

- (13) The registered owner of a dog may, whilst the dog is still in his physical possession, apply to have any or all of the following endorsements placed on the records of the dog and to have the relevant Registration and/or Transfer Certificate marked accordingly:-
  - (a) Not eligible for entry in Competitions held under Barbados Kennel Club Regulations.
  - (b) Progeny not eligible for Registration.
  - (c) Not eligible for the issue of an Export Pedigree.
  - (d) Name unchangeable.Should the breeder wish any of the above endorsements to be made in respect of any of the puppies now being registered, the appropriate code letter only need be entered in this column.

**OPTIONAL PEDIGREE SERVICE**

- (14) A Barbados Kennel Club Five Generation Pedigree may be obtained for any puppies. Simply add the current fee for each pedigree required and tick box overleaf.

**GENERAL**

- (15) If more than 10 dogs in a litter are to be registered, please use a further form attaching it to this form.
- (16) If a bitch has been served by more than one dog of the same breed in the same heat, the name of all dogs must be given when the litter is being registered.
- (17) Registration Certificates will be sent to the breeder for all the puppies in the litter.

**NON ACCEPTANCE OF REGISTRATION ETC.**

- (18) The Committee reserves the right to reject any application to register an affix or to register or transfer any dog or to change or cancel a name and may cancel or suspend any registration or transfer or grant of an affix already made.
- (19) The acceptance of a registration is not a guarantee of its accuracy.
- (20) WHEN SUBMITTED, THIS FORM REMAINS THE PROPERTY OF THE BARBADOS KENNEL CLUB.
- (21) Please allow at least 28 days for processing. If you write or telephone regarding an application to register a litter please quote the breed, the B.K.C. registration number of the Dam and the date of birth of the litter. If your application has been returned of you, please quote the litter number.
- (22) In the event that this form is returned to the Breeder for any technical reasons any further explanations or information required may be obtained by telephoning the registrar of the Barbados Kennel Club.
- (23) The General Committee may consider late registration by the breeder of dogs over the age of 6 months, subject to the current fee.

**NOTE**

**REGISTRATION OF IMPORTED DOGS ONLY**

When at the date of closing of entries for a show, an exhibitor has applied for, but not received, the Certificates of Registration, the dog may be entered in the name shown on this form, followed by the letters N.A.F. (name applied for).
